Forgave additional 4 months' rent (June through September) for PCMS and sent a link to Montana Covid Relief grants. There was one in particular for non-profits, and offered to assist in application if needed.
 - Reimagining Rural Webinar Hosting Phillips County got approved to host webinar watch party. Everything postponed due to Covid. Tentative planning to reschedule Fall 2020 – September (maybe).
